Don Henderson - the reason for this Ordinance is that the Parish Registrar of Voters indicated that the State Topographer stated that the Parish needed to update Precinct legal descriptions and boundaries.

Dwayne Wall - his office received a redistricting time line at the annual seminar and as of December 31, 2020 the precinct boundaries will freeze. These are the last items that need to be addressed, such as logging roads which were no longer there. The boundaries will be unfrozen in 2023.

Karlin Riles - read statement - the Civil Division has concluded that any commercial waivers requested will be considered by the Planning Commission, and any waivers filed by an individual would go before the Board of Adjustments. This version of the Ordinance reflect the actual changes to the Code as written. The previous strike-outs were proposed changes that were not in the Code. The meaning of the previous discussions has remained as intended.

David Campbell - he and the Little Tchefuncte River Association are in favor of this change.

Joan Simon - this is just the first step in this process and she hopes the Council approves it.

Terrice Moon, Elizabeth Mano, Barbara Henry - are in favor of this change.

Margie Vicknair-Pray - thanks the Council for voting in favor of this, and thinks they need to move forward with a lot more changes and clarifications.

John Martin - this ordinance is the cornerstone of the changes that need to be made.

Matthew Allen - The Parish has a right to legislate flood-plains. He does not want to stop development, he just wants everyone to be aware of flood-plain issues.

Denise Tabony - she no longer lives in Spring Lakes, but she wants to be an advocated for them because she was lied to by the developer and given written assurances that were not followed.

Michael Champagne - He would like to see no waivers at all. He feels that the problem with these developments is that there is no enforcement.

Al Hamauei - he represents the Chamber of Commerce, Home Builders Association, Realtors, etc. They are all concerned for the health and safety of the citizens, but they do not feel development does not hurt in this issue, and they do not support this amendment. They feel that additional analysis is needed along with more engineering involvement. They support further review of the Code in this matter.

James Harlan - he supports this ordinance and thinks the Council needs to consider the aggressive impacts of development on climate changes in the future.

Christopher Lee - he does not support this ordinance because he does not feel that it will help anything and will cause more cost to the homeowners. He asks that they search for an actual solution to this problem.

Lorino - he is committed to putting a new work group together to include participation from everyone.


