Ivan Milicevic - he is building a reception hall with wine tasting and was told he needed to rezone to add a parking lot of 200 spots.

Stefancik - he talked to Mr. Tanner - there is plenty of space to build the parking lot, and he wanted to override the denial.

Stefancik - moved to override the denial, second by Canulette. Unanimous with 1 absent (Tanner).

Stefancik - moved to introduce an ordinance, second by Canulette; becomes Ord. Cal. No. 6283.

Lorino - 4. Paul Mayronne, on behalf of All State Financial Company, appealing the failure of the Motion to Approve on October 9, 2019 the rezoning of 90.31 acres located south and west of Ochsner, west of Highway 21, Covington from PBC-2 (Planned Business Center) to AML (Advanced Manufacturing and Logistics District). (Ward 1, District 1) (2019-1530-ZC)

Dean - he would like to add 5 minutes debate time to each side.

Council Discussion ensued.

Dean - moved to extend debate time to 5 minutes per side, second by Blanchard. Motion passed with 11 yeas, 2 nays (Stefancik, Smith) and 1 absent (Tanner).

Paul Mayronne - Jones Fusell - the Zoning Commission vote to approve did not pass because it was a vote of 5 yeas to 3 nays and 6 yeas were needed for the item to pass. This request is to allow a building of 960 square feet with up to 1 million square feet for Medline Distribution Center. The request was for 90 acres, but now they are reducing it to 69.46 acres. This facility will be distribution only, no manufacturing. The property does not abut residential zoning on any side. Shady Lakes Subdivision is the closest to the building at 1/4 mile away. It is adjacent to I-12 and is surrounded by non-residential zoning. 26.21 acres of the property will be green space. The building will almost entirely camouflaged by foliage. It will be located further from residential than every other industrial zone in the Parish. The trucks they will be using comprise less than 1% of the traffic flow that currently exists. They have been operating on Highway 1077 for 15 years with no issue. There will be 2 shifts arriving and leaving in off-peak hours. No noise will be generated outside of the facility. Medline is prepared to donate \$500,000 to Shady Lakes for noise mitigation. Currently, there are 109 acres of retention ponds available for drainage storage, but they will also abide by a 30% reduction instead of the 25% required by the Parish. They also plan to add a first flush system to filter water before it reaches rivers, etc. They believe this project is preferable and causes less impact than PBC 2 (Planned Business Campus), which is the current zoning. PBC allows high intensity 200 foot buildings, 6 million square feet of business space and 18,000 parking spaces, among other things.

Chris Masingill - CEO, St. Tammany Corp. They were charged with bringing good jobs to the Parish, and the cost benefit analysis on this project should it will bring in \$18 million in tax dollars to the Parish.

Randy Loewen - they appreciate the extra 5 minutes. He is pro-business and pro-bono, they just want to show that this area is not the place for this project. The duty of the Council is to promote health, safety and welfare of the public. They think the traffic will be increased, not only by the Medline trucks, but also because of deliveries to the business and the employees coming and going. This area of the interstate is a death trap. They were 4 deaths in 2018 and some serious injuries yesterday. They don't need any percent increase in traffic in this area, but especially not truck traffic. He lives out there and everyone takes Highway 22 to avoid the interstate. The footprint of the area is bigger than the new terminal at airport, and with the added parking would be the equivalent of 6 Superdomes. People built in the area because of the Zoning, and citizens have a right to maintain their property value. They think this project should be built at the Slidell mall or on Highway 1088.

Barbara Jackson - she is on the Abita Springs Planning and Zoning Commission, when

industrialization hit in the 1800, it cause the need for the protection of the health, safety and welfare. She feels that we need to protect our citizens. This AML zoning is not appropriate.

Tess Crockett - this project was submitted to the Core stating that 43 acres of woodland and wetland would be affected. Wetlands take in a lot of water like a sponge. The future risks of a project are not completely known.

Joseph Bistes - he is a previous director of economic development for a distribution center and has an expertise in site selection. This area is not the right fit. If the Parish really wants economic development, then it needs to keep the current zoning in place to bring in a lot more tax dollars.

Dondyn Hassenbocher - she is here because Medline couldn't convince the Zoning Commission to rezone this property. There is no other AML zoning in the Parish. The promises of sufficient drainage and no increased traffic are just hypothetical.

Maria Mire - the Council needs to use sound rationalization. Marty Dean is not concerned for the citizens, nor are Wainer and Medline. Chemical productions can occur, and sterilization chemicals can be omitted into the air.

Mayronne - they want to reiterate that there will be no sterilization chemicals on the property, and he is pretty sure those type of chemicals are not allowed in the AML zoning. He would like the Council to consider that this development will have far less impact. If the site were to be built in Slidell, the trucks would still be heading west on I-12. The PBC-2 zoning was in place when most of the people in the surrounding areas bought their homes. PBC-2 zoning will allow up to 6 million square feet of buildings, and one 200 foot building would be more of an impact, than what Midline is planning.

Loewen - the fact is, if these trucks were entering I-12 in Slidell or Highway 1088, they would not be in the death trap. Deed restrictions make citizens vigilantes. Manufacturing is allowed in AML zoning, so if Medline were sold, then anything could be built there. The deed of sale states if the sale is not closed then Medline has to pay to rezone the property back to PBC-2.

Council Discussion ensued.

Marty Dean - read a statement into the record. The size of the districts shifted after the census. Most of the development in the Parish was in the west. He receives complaints every time a yellow sign appears.

Dean - moved to override the failure of the Motion to Approve at the Zoning Commission and amending the property to 69.4 acres, second by Blanchard. Unanimous with 2 absent (Tanner, Groby).

Dean - moved to introduce an Ordinance, second by Stefancik; becomes Ord. Cal. No. 6284.
