PRESENTATIONS

Bellisario - 1. Presentation of Proclamation to St. Tammany Parish Government Employee of the Month. (Brister)

Brister - presented to Chad Freeman, worked for the Parish since August 2010. Now works as a Utility Operator 2 in Department of Environmental Services.

Tim Brown - Director of Environmental Services - thanks Mr. Freeman's wife, Crystal, for allowing the Parish to borrow her husband for unscheduled events.

Bellisario - 2. Presentation of Proclamation of Achievement to Mickey Carroll. (Brister)

Brister - presented to Mickey Carroll, who is the next Louisiana State VFW Commander.

Bellisario - 3. Presentation by Qiana Wiggins with the United States Census regarding the 2020 Census. (Smith)

Qiana Wiggins - The census is to make sure resources are properly allocated. Louisiana only has 6 congressional seats, having lost one at the last census. The census Bureau does not ask for money. They are bipartisan, and do not share any information they receive. She asks that the Council pass a resolution to support and promote the Census in order to let the citizens know how important it is to be counted, once, only once and to tell the truth. The census is only 10 questions that can be completed on-line or by telephone. Reminders will start being mailed out starting in March.

Brister - the Parish is doing this to help save the citizens money because the previous fee was the same fee as a full build-out rather than just adding on to an existing structure.

Tanner -can we make it no charge?

Brister - if that is what the Council wishes, yes. This new fee is the cost of sending an inspector to view the ramp.

Tanner - moved to introduce, second by Canulette.

Chief Moore - as the parcel fee election failed, they are doing this to pay for the personnel and build two new fire stations. They have areas of the district that they cannot meet within the mandated response times. One of these issues dealing with is that they have 4 stations which are from 30-50 years old, and now the stations need to be renovated. They plan to reshuffle funds and priorities in order to cover the payment of the Bond.

Council discussion ensued.

This is about selling alcohol within 500 feet of schools, churches, synagogues, correctional facilities, etc. He feels 500 feet is plenty, and that is someone needs less, they should apply to the Board of Adjustments.

Thompson - State Law and all of the cities in the Parish are at 300 feet. This is hurting the Mom and Pop Stores in the rural areas, and he wants to make the law consistent with the State and cities.

Thompson - moved to adopt, second by Dean. Motion passed with 12 yeas, 1 nay (Groby), and 1 absent (Lorino).

Bellisario - 14. Ord. Cal. No. 6191 - Ordinance to amend the 2019 Operating Budget - Amendment No. 6. (Toledano) (Introduced 6/6/19)

Toledano - moved to adopt, second by Fitzgerald. Unanimous with 2 absent (Dean, Lorino); becomes Ordinance C.S. No. 19-4109.


