Carl Ernest - he wants to speak on the rightness of this issue. The vote last year was 66% saying to leave it the way it is. He feels that this is an intent to subvert what the voters stated they wanted. If, as a member of the military, he had done this, he could have been charged criminally or dismissed. Please follow the orders of the public and do what they asked to do.

James Blasik - he is the legal advisor of CCST. He asks the body to defer this vote for the reason that Judge Marion Edwards, who was asked to come in and decide this issue, will hear this issue in the next several weeks. He feels this is a slap to the court. The people overwhelmingly spoke on the issues in favor of leaving it alone. They feel that the DA, who was elected, is doing a good job. He would ask that the DA be given the chance to do as the Charter states.

Rick Franzo - he asks the Council not to support this ordinance because of the existing litigation. He feels that this circumvents the people's vote, and thinks it is wrong to the citizens of the Parish.

Kevin Coleman - The Charter, Section 4-03, states that the District Attorney is the attorney for the Parish Government. Treason is defined as betrayal.

Donald Lee - he thinks this is a bad idea at this moment to adopt these ordinances. The former DA overstepped his authority by forcing the Council and President to take his choice as attorney. The lawsuit is pending, against the vote of the people. It is highly likely that the State will support the DA as legal authority for the Parish. He urges the Parish to take a different tack to work with the DA.

Stefancik - moved to introduce, second by Blanchard.

Samantha Hamilton - she is trying to put a trailer on the property to be able to eventually build a home on it. She bought it for that purpose.

Patricia Wesley Smith - she is a member of a group from Browns Village who are concerned if this land is large enough for this use. They also want to make sure the trailer will be owner occupied, and will contribute to the beauty of the area. They fell the addition of a manufactured home will be a detriment to the beauty of the area. Previously, MHOs have not been owner occupied and were just abandoned. They are opposed to the creation of this overlay in this area, which is mostly single family homes.

Jamie Lindsay - he is from Bush, and is trying to help Ms. Hamilton become a homeowner. The neighbors nearby have a gate and looks as if it is being used as storage and is overgrown with weeds. Behind the property is a brick house, which is in disrepair, and an abandoned car in the yard. He feels that this is the best use for this area of Browns Village. The houses they spoke about are to the left. Please approve.

Smith - he has reviewed this matter cautiously for both parties. In this Parish, there is a significant lack of affordable housing/workforce housing. The renters in this parish are putting 33% of their income into housing. The most affordable house are \$130,000 to \$150,000. This trailer will be owner occupied and there are 6 mobile homes nearby.

Thompson moved to adopt, second by Lorino. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3571.

Dean - 18. Ord. Cal. No. 5634 - Ordinance amending the official Parish Zoning Map to reclassify 17.15 acres located on the east side of LA Highway 21, north of Money Hill Drive, south of Esbon Drive from A-2 (Suburban District) to HC-2 (Highway Commercial District). (Ward 5, District 6) (2016-255-ZC) (Zoning Commission approved 6/07/16) (Introduced 7/7/16)

Tanner - moved to adopt, second by Groby. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3572.

Dean - 19. Ord. Cal. No. 5635 - Ordinance amending the official Parish Zoning Map to reclassify 24.14 acres located east of LA Highway 1077, north of Tantela Ranch Road from A-1 (Suburban District) to A-2 (Suburban District) and A-3 (Suburban District). (Ward 1, District 3) (2016-261-ZC) (Zoning Commission approved 6/07/16) (Introduced 7/7/16)

Thompson - moved to adopt, second by Lorino. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3573.

Dean - 20. Ord. Cal. No. 5636 - Ordinance amending the official Parish Zoning Map to reclassify 9.1 acres located at the southeast intersection of Brewster Road and River Chase Drive from NC-5 (Retail and Service District) to A-5 (Two Family Residential District). (Ward 1, District 1) (2016-264-ZC) (Zoning Commission approved 6/07/16) (Introduced 7/7/16)

Thompson - moved to adopt, second by Sharp. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3574.

Dean - 21. Ord. Cal. No. 5637 - Ordinance establishing a No Parking on Pavement Zone on Portion of Melissa Lane. (Ward 3, District 2) (Introduced 7/7/16)

Sharp - moved to adopt, second by Lorino. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3575.

Dean - 22. Ord. Cal. No. 5638 - Ordinance to amend the St. Tammany Parish Code of Ordinances, Chapter 2, Administration, Article III, Parish Council, to add a new section entitled: Council Personnel. (Introduced 7/7/16)

Rick Franzo - CCST strongly opposes this. If the Council decides to vote yes on this, as it is set up creating a Council legal department, is doing something that is illegal, and the Council members could be charged with malfeasance in office.

Stefancik - moved to adopt, second by Blanchard. Motion passed with 12 yeas, 1 nay (Groby), 1 abstention (O'Brien), and no one absent; becomes Ordinance C.S. No. 16-3576.

Dean - 23. Ord. Cal. No. 5640 - Ordinance to impose a six (6) month moratorium on receipt of submissions by the Parish Planning and Zoning Commissions for the re-subdivision or rezoning of property and/or on the issuance of permits by the Parish Department of Planning & Development/Permits for the construction or placement of any building structures on property in the area known as Tammany Terrace Subdivision. (Ward 3, District 2) (Introduced 7/7/16)

Sherri Barton - she is a resident of Tammany Terrace. They have petitions with a total of 700 plus signatures in favor of this moratorium to allow time to address traffic and drainage issues.

Ben Bryant - the residents of Tammany Terrace are in support of this moratorium. He has photos of the drainage issues from the rain in February. All of the sewage and stormwater flow to just 2 drainage ponds. He is asking for this delay of 6 months, so drainage issues can be reviewed before more residents are added.

John Zollinger - he is the president of the bank supporting the Northshore Housing Initiative. It is the duty of the leaders of the Parish to help support those who may not be able to buy a house. They only help those who can qualify for a conventional loan. They have already helped two single mothers and a military member buy houses. This is about home ownership in the right way.

Shiloh Moates - she is the architect working on designing workforce housing based off of starter houses which are designed to fit in with the existing houses in the area. The houses have 3 bedrooms and 2 baths and are market rate homes. They are 1900-2000 square feet under beam and have a country cottage esthetic. They are designed to meet energy savings standards, which lowers utility. She would hate to see people lose their funding because of this moratorium.

Shawn Macomber - he is the Northshore Housing Initiative Chairman. The plan in this area is to build 16 workforce houses over a 4 year period, starting with 2 homes. This will leave ample time for drainage and traffic issues to be reviewed before their project is completed. They have a federal grant to build these 16 homes, and the loss of funds could cause economic damage, plus make future grant money difficult to obtain. He feels this is an unnecessary and punitive moratorium.

Bellisario - he is concerned with the potential loss of the grant money and would to consider the reduction of months of the moratorium to allow for study, but prevent the loss of the money.

Smith - he is very much in support of workforce and affordable housing, and it would be hypocritical to support this after the Ordinance he just passed.

Blanchard - this is primarily for first responders, teachers, etc.? If this moratorium is passed, they grant will be lost?

Macomber - the NIH provides money to purchase the land. The buyer has to get approval for the loan. The NIH owns the land. They are a non-profit group run by volunteers. If the NIH no longer exists, the land will return to the Parish, and yes, they will lose the grant is this is passed.

Patricia Brister - this is a land grant, which makes it permanently affordable. It is a never ending lease.

Macomber - even if the original owner sells the house, they will not make a profit. The land will still be owned by the NIH. This is a program to create long-term affordable housing. Home owners have to be approved for the loan and they sign an equity agreement that if they sell, they land remains with the NIH.

Brister - it is no different than the way condominiums are bought.

Council Discussion ensued.

Tanner - the problem is that this is about a paper subdivision established in the 1930s. There is no way to answer all of the questions in a month. They need to put the moratorium in place and get to work on this now.

O'Brien - moved to postpone, second by Smith. Motion failed with 3 yeas (Bellisario, O'Brien, Smith), 10 nays, and 1 recusal (Toledano).

Bellisario - moved to amend the moratorium to 3 months instead of 6, second by Blanchard. Motion failed with 5 yeas (Bellisario, O'Brien, Stefancik, Artigue, Smith), 8 nays, and 1 recusal (Toledano).

Sharp - moved to adopt, second by Thompson. Motion passed with 10 yeas, 2 nays (O'Brien, Blanchard), 1 abstention (Bellisario), and 1 recusal (Toledano); becomes Ordinance C.S. No. 16-3577.

Dean - 24. Ord. Cal. No. 5641 - Ordinance amending the official Parish Zoning Map to reclassify 80.37 acres located north of Westshore Drive Extension and north of Pinnacle Pkwy from A-4A (Single Family Residential District) to A-4A (Single Family Residential District) and PUD (Planned Unit Development Overlay). (Ward 1, District 1) (2016-257-ZC)

Stefancik - moved to adopt, second by Groby. Unanimous with no one absent; becomes Ordinance C.S. No. 16-3578.

Toledano - Majure Savell no longer desires to serve.

Toledano - moved to reappoint Thomas Laizer, III, Robert Bergeron, Pete Perrson, second by Lorino. Unanimous with no one absent; becomes Resolution C.S. No. C-4643.

Dean - 4. Resolution to appoint one (1) member to Recreation District No. 4 to replace Anthony Thomas (resigned). (Leonard Schmidt has requested appointment)

Groby - moved to appoint, second by Bellisario. Unanimous with no one absent; becomes Resolution C.S. No. C-4644.
