Tanner - 1. Jeanne Stangle and Barbara Dodds appealing the Zoning Commission DENIAL on February 3, 2015 for a Text Change to the Parish Code of Ordinances, Section 7.06 Accessory Buildings and Structures regarding the permitted size of boat houses on designated scenic streams. (ZC15-02-017)

NOTE: To concur with Zoning DENIAL, a simple majority vote is required and adoption of a resolution.

NOTE: To override Zoning DENIAL, a majority vote of the entire Council is required and adoption of Ord. Cal. No. 5307, introduced October 2, 2014, and scheduled for Public Hearing on April 2, 2015.

Barbara Dodds - League of Women Voters - they are appealing the Zoning Commission's decision to reject the language submitted to them by the Council. The Commission had no real reason as to why they denied the Ordinance, and there seemed to be some confusion over what they were even voting on. Boat houses on scenic rivers are the only ones which will be affected by this Ordinance. Boat houses on canals and the lake will not be affected.

Jeanne Stangle - she has lived on Bayou Liberty for 39 years, and they have been lobbying for legislation to include Bayou Liberty as a scenic river. She does not think the general public's lived would be enriched by large boat houses. She asks them to please preserve scenic rivers.

Gould - Mr. Fontenot, what was the reasoning of the Zoning Commission for denial?

Sidney Fontenot - the Commissioners were confused about the scenic stream designation, and one of the commissioners was concerned for clients who wanted to be able to put up any size of boat house.

Council discussion ensued.

Stefancik - moved to override the Zoning denial, second by Bellisario. Unanimous with no one absent.

Tanner - the Ordinance for this was introduced in October and will be heard at the April 2, 2015 meeting.

Noella Thonn - she lives in Jefferson, Louisiana. She was told she could not subdivide her property because she would need a new sewer system, and there were too many systems in the area already. The area is full of 100 foot lots, and she feels that subdividing her lot would not cause more sewerage issues. She is trying to dispel her mother's estate, and she cannot sell the lot because of its current lot size.

Gould - he drove the area, and it is a mixed bag of zoning back there. The staff recommended denial because of DEQ problems. The Parish is trying to solve the sewage and water problems in the area. Also, there is a lot of runoff from those problems. He does not feel that only making a profit by splitting the property is a compelling reason to create two new substandard lots.

Gould - moved to concur with the Planning denial, second by Falconer. Unanimous with no one absent.

Gould - moved to adopt a resolution, second by Bellisario. Unanimous with no one absent; becomes Resolution C.S. No. C-4302.

Stevens - she and Ms. Fruchtnicht feel that the Sharp Road Drainage has something to do with Dove Park.

Gould - again, Ms. Stevens is also a party to the lawsuit and is trying to further her cause. This is not germane to the subject.
