PRESENTATIONS

Binder -1) Presentation by Chief Gary Mendow and Greg Lemons regarding the fire rating of Fire Protection District No. 8. (Crawford-Howell)

Crawford-Howell - Greg Lemmons is going to speak about the fire rating of Fire Protection District No. 8, which covers Districts 2, 3, 6 and 7.

Lemons - member of the Fire District Board, this Fire District covers Ward 10, the Abita Walheim area. The main station is in Abita Springs. In the early spring, their fire rating was a 5, but due to an increase in man power from 9 members to 17, the fire rating was reduced to a 4 in May. Due to the decrease in the fire rating, the insurance for the residents in this fire district will go down. Chief Gary Mendow wanted to speak; however, he was called away on a fire call.

Falconer - moved to move Item No. 20 under Ordinances for Adoption to the start of the Consent Calendar, second by Thompson. Unanimous with 2 absent (Stefancik, Burkhalter).

Binder - 20) Ord. Cal. No. 4127 - Ordinance to amend the Parish Unified Development Code, Volume I (Zoning) Section 5.30B PF-3 Public Facilities District relative to Title and Permitted Uses. (ZC09-07-020) (Introduced 8/6/09)

Paul Mayronne - speaking on behalf of Jeff Schoen, read a statement into the record regarding Richard Blossman's objection and opposition to this ordinance.

Reid - moved to adopt, second by Bellisario. Unanimous with 2 absent (Stefancik, Burkhalter); becomes Ordinance C.S. No. 09-2131.

PUBLIC HEARING

Binder - Public hearing in accordance with open meetings law R.S. 42:1, et seq for consideration and adoption of Resolution C.S. No. C-2686 - Resolution establishing millage rates for the year 2009. (Binder/Davis)

Binder - asks that all speakers keep statements brief, and if they hear someone else express their opinion to refrain from repeating.

Frances Amatto - according to the proposed millages it appears that there will be a reduction of 15% in millages. However, the Assessor sent a letter saying that he would be paying 15% more. It looks like the Parish is just trying to appease residents and not doing anything to solve the problems.

Binder - he wants to clarify the 2 segments that make up property taxes. The first part is the assessment of the property by the Parish Assessor. None of the taxing bodies, such as the Parish, the Fire Districts, the school board or the library, have a say in what the assessment of a house is. The only thing the Parish and other taxing bodies can decide is whether to roll millages forward or back.

Sevante - 2008 was a reassessment year. Once the assessor completed assessing all of the properties in the Parish, she set the adjusted millage rate based on information from the pervious year, plus growth. When the Council adopted the adjusted millage, it indicated that it would collect the same amount of money in 2008 as in 2007. Now, in 2009, the Parish is saying that it will not collect any more taxes than it did in 2007 or 2008.

Amatto - then why am I paying more taxes?

Binder - if the Parish stays at its adjusted rate, then the Parish remains revenue neutral because some citizens' assessments may have gone down while others have gone up.

Hall - everyone needs to understand that the increased assessed value of your property, even if all of the millages remain the same, will increase property taxes. Taxes will still go up because of the drastic increase in the assessed value.

David DeVun - he went through the appeal process last year, the Board of Review modified his assessment. He paid his taxes and the assessor cashed his check, but then 6 weeks later he received an additional bill. He appealed to the State Tax Commission and went to Baton Rouge, but it was like a Kangaroo Court that lasted all of 10 minutes and he lost. He asked what recourse he had to appeal the Tax Commission's decision and was told that he needed to have the legislature pass a bill. He knows that will not help because only 7 Parishes in Louisiana had assessment issues, so the law will not be changed. He received notice in the mail today from the assessor that his taxes were going to be raised another 15% this year.

Binder - the assessor is duly elected in each Parish. Last year the assessor received 15,000 to 20,000 appeals. 2000 of those were appealed to the Council as the Board of Review. The Board worked 8-9 nights and Saturdays to hear all of the appeals. The Assessor appealed a lot of the Board of Review decisions to the Tax Commission. The Council wanted to represent those who were appealed, but the law does not allowed that. The Council has heard that the decisions were not fair. Unfortunately, that has to be changed at the State level. The Council members have spoken to the State delegates and all of the delegates are upset. The only other recourse, if the appeal is denied by the Tax Commission, is to file suit in court.

Falconer - he is shocked that Mr. Devun is able to present a letter stating that his assessment is going up by 15%. The Assessor stated that the 2009 taxes would be based on the Fair Market Value as of December 31, 2008. The Consumer Price Index is down for the first time, so the assessments should be down also. He encourages everyone to take advantage of the Assessor's rolls being open and file an appeal with her.

Sevante - the Assessor's rolls will close on September 15th. The Board of Review has to receive all appeals no later than September 24th.

DeVun - the assessor told his wife that the Board of Review process is a joke.

Binder - the Board's decision is law if the Assessor does not appeal.

Falconer - it is important to file with the Assessor and the Board at the same time. You are filing a request for a review with the Assessor and an Appeal with the Board.

Bellisario - he would like for all of the citizens who receive an increase this year to let the Board know if they also filed an appeal last year.

Cathy and Bob Lorio - they reviewed the Assessor's website and discovered that a bunch of people on the west end of the Parish had there assessments lowered, including the assessor and her entire neighborhood. Kevin Davis' assessment stayed the same. Lorio is an attorney and he went to the Tax Commission and won his appeal, but this year he received a letter that his taxes are increasing by 15% anyway.

Binder - he lives on the east side of the Parish and his assessment went up drastically. Last year, he, Mike Sevante and Gene Bellisario went to Baton Rouge to meet with the Tax Commission. They spoke to the Tax Commission representative for the Parish and told them all of the horror stories citizens had reported to the Board. The representative was not sure why all of the horrors occurred. Not long after the meeting, the commission attorney was fired from the tax commission. Clearly, the system is broken. The requirement to have the Board of Review is not only state law, but it is in the Louisiana Constitution. Still, the Board's decisions went to the Tax Commission and fell on deaf ears.

Hall - unfortunately, he was not allowed to represent any of the taxpayers, which he would have loved to do. Instead, he composed a legal memo detailing the proper procedures of the Assessor, the Board and the Tax Commission. He also had the Commission make the memo part of each taxpayers' record, which the Commission did. The Assessors rolls are currently open for review. He wants to make it clear that the citizens are not filing an appeal with the Assessor, they are requesting review of their assessment. The only appeal is to the Council as the Board of Review. His personal and legal opinion is that the Assessor should not be able to appeal the Board's decision because the only parties with an interest in the assessment process are the citizens and the taxing bodies.

Lorio - for his hearing with the Tax Commission, he subpoenaed his records from the Assessor, but she never provided him with anything. Then, she brought the records to his hearing. He protested her submission of the records, but the Tax Commission allowed the records to be used. He did win, but now he has to deal with the retribution. He wants to point out that the assessment of the Assessor's house went down by \$70,000.

Binder - the Tax Commission has got to act in an impartial manner. If the homeowner is right, then they should win and vice-versa. The Board only lowered people based on good information, then the good people had to go to the Tax Commission, and then they were not given the time of day.

Kevin Davis - he would like to review the letter stating that the taxes are increasing by 15%. The taxes should have been set by now, and he does not see how raising them again can be legal. All of the assessments are supposed to be completed, as she is giving the information to the taxing bodies so that they can make their millage decision. Do we need to file a Class Action suit?

Hall - there had been some question as to whether or not there would be a partial reassessment this year. That may be why the letters were sent out.

DeVun - how long can the Parish continue to roll back the millages without services suffering?

Davis - the Assessor also receives a millage. It seems like the people who appealed to the Tax Commission last year are the ones receiving an increase this year.

Hall - the various taxing bodies have the right to appeal and file a lawsuit.

Chris Wells - he bought a house in Golden Shores at an inflated price after Katrina. Now a lot of houses are selling for way below their appraised values.

Jim Regal - for 4 years, he has paid 10 times the amount of taxes as his neighbor. The system needs to be more homogenized.

Rob Meyer - his comments are going to cut across the grain. He read in the newspaper that the City of Mandeville is giving its employees raises. Just today he saw police officers standing around talking in the front of the neighborhood with their cars running. Why can't the government just cut spending?

Bill Smith - he had 20 properties that were assessed at 200% higher. He was able to negotiate a number of them, but also had to appeal some to the Board of Review. He has already received a 15% increase letter on one of the properties, and he has not even had his hearing in front of the Tax Commission from last year. The problem is with the revenue neutral portion of the Code. It is just words, it does not compute.

Davis - the Parish Government is mainly run on the Alimony Tax. They were told last year that they would make \$3.8 million. They have only collected \$3.4 million. Still, they are telling taxing bodies not to roll up, so that it helps the people, but with high assessments, people are still seeing a tax increase.

Sevante - he spoke to the Sheriff who is the one that actually collects the taxes. The numbers suggest that 98% of residents in St. Tammany paid their tax bill. There have been 6000 change orders by the Assessor to adjust assessments down. That could explain the shortfall in revenue.

Falconer - moved to adopt, second by Gould. Unanimous with 2 absent (Stefancik, Burkhalter).

Rita McDonald - lives in Crestwood near the playground. Crestwood is concerned that a tree buffer will not be left when the new road and apartment complex are built.

Fontenot - tree buffers are not a rezoning issue.

Cindy Bryer - adding more apartments to St. Tammany is just causing the area to become more like Metairie. There main concern is the tree buffer. The continuation of Emerald Forest Blvd is a good thing, but the buffer is needed. The President of the Civic Association thinks that the trees are going to be cut down and a fence built.

Binder - the time to deal with this issue is when the project begins.

Bryer - no, the time is now before the land is sold again or something else is built. Now is the chance to get the land. Somebody needs to talk about the proposed road and the thought of cutting down the tress will destroy the quality of life for Crestwood. There are a lot of voters in Crestwood that could sway a vote of the Council.

Don Lobb - he wants to know if the deed restriction exists to make sure a buffer is put in on 1085 to ensure that any commercial cannot be seen from the road. The main industry in St. Tammany is land, and, when you take it away, it changes the ambiance.

Paul Mayronne - his clients are committed to the deed restriction. The fact of the vote tonight will not hinder the progress of negotiations with Mr. Dean. Also, read statement from Jeff Schoen regarding Mr. Blossman.

Gould -he would like to have the engineer from Utilities, Inc. explain what happened.

David Scalapano - the lift station at Crestwood had some odor issues. The odor was not from the lift station itself but from a hole in a pipe that was damaged by construction. They changed the fitting and still have carbon canisters to help control any remaining odors. The multi-year plan is to send some of Crestwood's water through a new lift station near Lowes and then eventually to a much bigger lift station.

Mr. Williams - for Utilities, Inc. he would like to emphasize that the Arrowwood/Northpark facility is a regional facility that handles over 8 miles of south Covington and north Mandeville. Over the years they have added a 2nd drainage route and are planning a 3rd to make sure they continue to have the capacity they need to serve.

Gould - has the odor gone away since the pipe was fixed?

Bob Reise - Crestwood - the problem has been addressed and there are no more odors.

Gould - Mr. Gordon - do you concur with the analysis of the system?

Greg Gordon - Environmental Services - yes. It works. The pipes have been fixed and the new station will help relieve the system. All of the issues have been addressed.

Gould - in your opinion, is this moratorium still warrented?

Gordon - no.

Gould - moved to remove from the agenda. second by Crawford-Howell. Unanimous with 3 absent (Falconer, Stefancik, Burkhalter).

Binder - 14) Ord. Cal. No. 4121 - Ordinance amending the official zoning map of the St. Tammany 2009 South Central Comprehensive Rezoning Area One (CRA-1) to reclassify land located in Sections 16 & 21, Township 7 South, Range 13 East containing 20.5661 acres from A-4 (Single Family Residential) to A-4-A (Single Family Residential).
