No. 12-2707, adopted April 5, 2012 and codified as Sec. 40-333(A) of the Code of Ordinances of the Parish of St. Tammany, which established and validated fees for sewerage and water services provided by systems owned and operated by the Parish. (Binder/Cooper) (Introduced 10/06/2022) (Postponed until February 2023 on 11/03/2022)

-Smith – moved to refer to the full Council for postponement, seconded by Binder. Unanimous with 2 absent (O'Brien, Airey).

-Tanner - 15. Ord. Cal. No. 7187 - An Ordinance amending the official zoning map of St. Tammany Parish, La, to reclassify a certain parcel located on the north side of LA Highway 22, east of Belle Pointe Drive, west of Perrilloux Road, Madisonville and which property comprises a total of 3.010

acres of land more or less, from its present HC-1 (Highway Commercial District) to an HC-2 (Highway Commercial District) (Ward 1, District 1). (2022-3068-ZC) (Dean/Cooper) (Introduced 01/05/2023)
