### 107 - JUDICIAL COURTS FUND

To adopt the budget for a new fund. Ordinance Calendar No. 7045AA was adopted at the August 4, 2022 Council Meeting, at which the Parish ordained the Clerk of Court to increase certain fees in accordance with the provisions of R.S.13:62. The Ordinance includes the Parish Council's dedication of the revenues to be used directly and exclusively to fulfill St. Tammany Parish's legislative obligations to cover the operational expenses of the judicial system and provide for a good and sufficient Court.

The expenditure budget includes the 5% collection fee to the Clerk for \$19,750 and \$276,500 for the 22nd Judicial District Court.
