Administrative Comment Amendment No. 11 - 2022 Operating Budget - September 2022

This budget amendment is to:

a. 000 - GENERAL FUND

To amend the budget to increase revenues for the allocation of Coronavirus State and Local Fiscal Recovery Funds (SLFRF), a part of the American Rescue Plan. The program ensures that governments have the resources needed to maintain vital public services, even amid declines in revenue. The final rule offers a standard allowance for revenue loss of up to \$10 million, to use that amount for government services.

To amend the budget to increase expenditures for the Jail, District Attorney's Office, City Court of East St. Tammany, Registrar of Voters, and JPs/Constables.
