Please be advised that there will be an increase in some permit fees for the following permit classifications; Commercial and Residential electrical, mechanical, plumbing and gas. There are also several other Development and Environmental permits that will see an increase. Fee increases will become effective August 11, 2022.

Residential Plan review fee	\$50.00 plus \$0.01 per square foot
Mobile Homes	\$100.00 plus \$0.10 per square foot
